### RESERVATIONS

To reserve space, submit the application form with a deposit of \$500. If space is available, you will be sent immediate confirmation, a medical questionnaire and other pre-departure information. Please notify us of any special needs or requests, including extending your stay or upgrading your flight class at your own expense.

### 2026 CANCELLATION & REFUNDS

Cancellations must be received in writing to Spirited Adventures Travel. Payments are non-refundable except amounts indicated, dependent on costs incurred.

From initial deposit: \$250 refundable (before Jan 15)

Jan 15 - Feb 28: up to \$1000 refundable (after 2nd payment)

March 1 - March 15: dependent on payments/costs incurred

March 16 - departure: 100% non-refundable

We recommend that all clients enroll in a travel protection plan (see insurance section). It is understood and agreed that there will be no partial refunds for unused hotel rooms, hiking arrangements, sightseeing, guide costs, etc. for any reason.

### INCLUDED IN TOUR PRICE

Transportation, accommodations, meals as specified, taxes and gratuities to hotel and restaurants, 1-2 bags (as specified by airline) per person, guided sightseeing, entrance fees, and other services and experiences listed.

### NOT INCLUDED IN TOUR PRICE

Increases imposed by the airline that may be in place by time of ticketing or travel. This includes adverse currency exchange fluctuations, airline imposed security and fuel related surcharges and foreign or domestic tax increases. Personal expenses - passport fees, insurance, medical or hospitalization costs, emergency evacuation, laundry, cleaning, additional telephone or internet usage, optional excursions or itinerary changes, excess baggage charges, flight class upgrades, beverages, additional meals/snacks, additional transportation, political issues or natural disasters, or other causes beyond our reasonable control. Plan for tips for meals/services on your own, as well as customary tips for Tour Guide and Driver.
